### 5. Exam Readiness Package

- Test knowledge using the pre-certification exam,
- Review and discuss the results of the pre-certification exam,

- Create a study plan to prepare for the exam, and
- Identify effective test-taking strategies that can be used to answer exam questions.

### 6. Certification Exam

- The Certification Exams will be designed and developed specifically for the EU CloudCamp4SMEs program and will draw on questions that cover from the courses.
- The exam will be completed by the alumni online and it will vary between 1-2 hours, based on the pathway.
- Exam questions will be multiple choice, random, and scored, with a passing score equal to 80% of correctly answered questions.

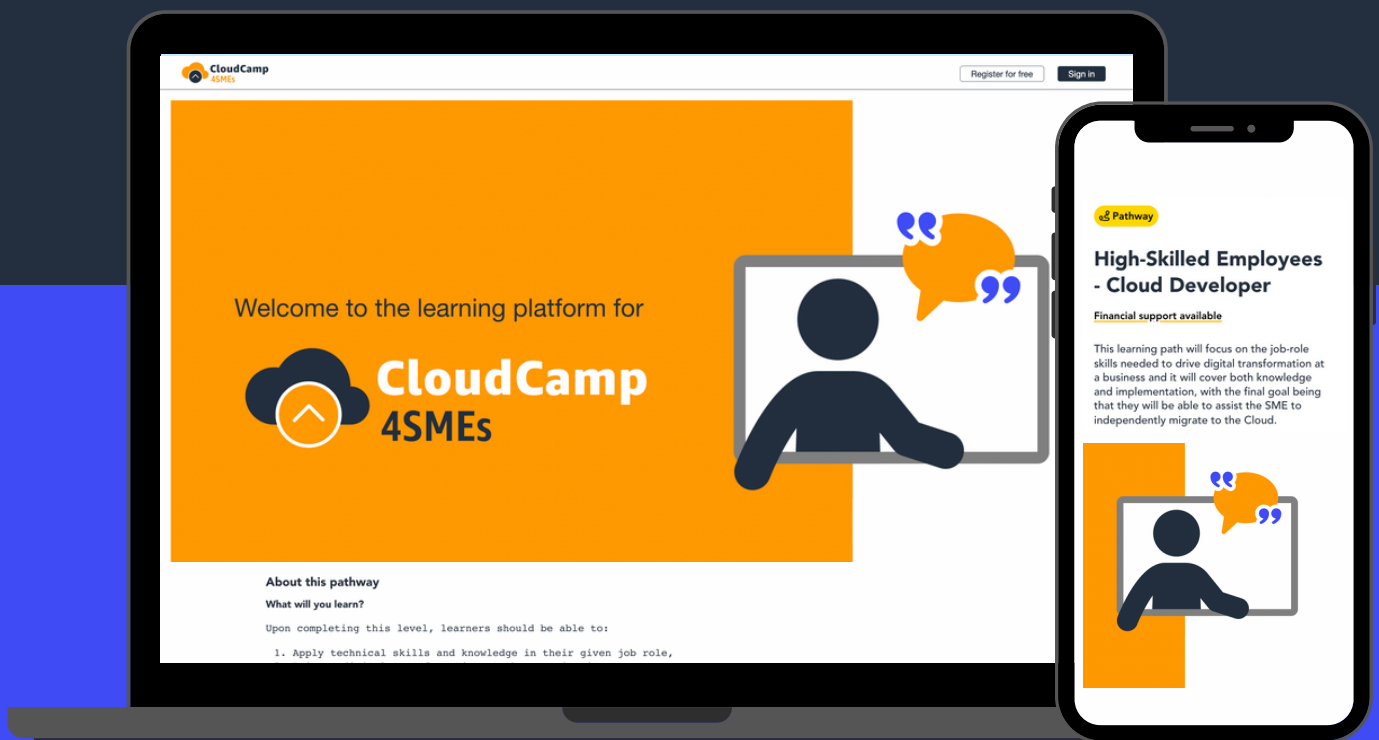
